

ALPHA PSI OMEGA CONSTITUTION

ARTICLE I: NAME

Section 1: This organization shall be known as the Sigma Phi cast of Alpha Psi Omega.

ARTICLE 2: OBJECTS

Section 1: The objects of Alpha Psi Omega shall be:

- *To recognize those students with special achievements and constant participation in Elizabethtown College theatre.
- *To promote the expansion and enjoyment of the performing arts for the Elizabethtown Community.
- *To provide privileged membership to the national fraternity of Alpha Psi Omega.

ARTICLE 3: MEMBERSHIP

Section 1a: Members of Alpha Psi Omega shall be drawn from the Elizabethtown College Community.

Section 1b: Members must meet requirements delineated by the point system of the Sigma Phi cast of Alpha Psi Omega (see figure 1).

Section 2: Members are required to attend 50% of all general meetings and must be present at induction to be considered a full and active member and thus be entitled to all privileges of membership.

Section 3: The induction fees as described by the national fraternity will be paid.

ARTICLE 4: MEETINGS

Section 1a: General meetings of Alpha Psi Omega will be held as necessary, giving members ample notice.

Section 1b: Members who wish to include something in general meetings must contact an officer with a brief outline of the topic and its relevance to the group prior to the meeting.

Section 2: At least one officer shall preside over general meetings, promptly providing the absent officers with the minutes.

ARTICLE 5: OFFICERS

Section 1: The positions of president, vice president and business manager shall be filled by members of Alpha Psi Omega that have been elected by the majority of the club. Optional positions may be created and filled as present officers see fit.

Section 2a: The duties of the president shall include: calling meetings; overseeing the induction of new members; following up on those eligible for membership; organizing ceremonies and fundraisers for the club. The president may not simultaneously hold the office of presidency in Sock and Buskin.

Section 2b: The duties of vice-president shall include: standing in for president when she is unable to fulfill tasks; composing minutes for all meetings; overseeing committees.

Section 2c: The business manager's duties shall include: overseeing the club's budget; maintaining an organized budget portfolio; maintaining contact with the senate organization of Elizabethtown College.

ARTICLE 6: INDUCTION

Section 1: Prospective members must meet the point system requirements set forth by the Sigma Phi cast of Alpha Psi Omega. Prospective members must also be in attendance at the induction ceremony.
